**MEMBERSHIP AGREEMENT**

Membership will be subject to all Club Rules and Regulations and to the following:

- 1) Member will be responsible for all charges signed for by member or member's family, or incurred by the use of member's card whether or not authorized until Deer Creek receives written notification the card is lost or stolen.
- 2) Member will be responsible for damage to any property of Deer Creek, caused by member or member's family, guests or invitees.
- 3) All goods and services are invoiced monthly and are payable upon receipt in cash or by check. Member will pay interest at 18% per year on all sums not paid within thirty (30) days after the date of invoice for such sums, plus collection, court costs, and attorney's fees incurred in collecting such sums. Charging privileges may be suspended if member's account is more than sixty (60) days delinquent.
  - a) If account remains unpaid past 120 days, membership privileges will be terminated.
- 4) Membership fees are not refundable for any reason, and membership privileges are not assignable unless approved by Deer Creek.
- 5) Membership privileges may be revoked by Deer Creek for violation of Club rules & regulations.
- 6) Use of the Club facilities is at the sole risk of the member, and member waives any claims for loss or damage to member's property in connection with member's use of the Club facilities.
- 7) Member agrees to hold Deer Creek harmless for any and all injuries incurred while on Deer Creek property.
- 8) Renewal of this membership is subject to prior approval of Deer Creek in its sole discretion.
- 9) All facilities, equipment, hours, prices, services, rules, regulations and policies of the Club are subject to change at the sole discretion of Deer Creek without notice.
- 10) Member acknowledges that membership is not an investment in the Club, dues or other assessments are pre-paid user fees, and do not create or convey a legal or equitable property interest of any kind, nature, or description whatsoever in either the Club or the Club facilities.
- 11) Member use is limited to the facilities at Deer Creek and does not extend to any other properties.
- 12) Member acknowledges that at Deer Creek's option, the Club may be closed for routine or necessary maintenance repair.
- 13) Member acknowledges that Deer Creek is sole owner of the Club and all Club facilities with the sole right to operate the Club and Club facilities. These rights include but are not limited to:
  - a) The right to change or discontinue operation of the facilities.
  - b) The right to exercise any and all other rights of ownership including the right of sale to others.

Membership in the club will be governed by these terms and conditions, and the Club rules and regulations. Such terms, conditions and rules and regulations will be determined by Deer Creek in its sole discretion. Ownership of a home in the community in which the Club is located confers no membership rights upon the owner, nor any right to make application for membership, nor any right to make use of the golf course or other related facilities. Fees charged for the use of the golf course and clubhouse and membership in the Club are subject to the sole discretion of Deer Creek and may change without notice. No representation is made regarding the type or availability or number of memberships that Deer Creek may offer from time to time.
